## Show Conditions

- **COVID-19**

**THIS SHOW WILL BE RUN FOLLOWING THE COVID-19 PROTOCOLS OF HARRIS COUNTY, TEXAS AND GOVERNOR ABBOTT'S PLAN TO RE-OPEN TEXAS**

- Masks or face coverings must be worn at all times except when mounted. **This is a Harris County Ordinance as well as facility requirement**
- Social distancing will be required and enforced.
- There will be no chairs or tables in the stands, please bring your own.
- To limit congregating in the barn areas no community chairs or seating setups will be allowed in the main aisle way or barn aisles. Individual chairs may be set up but with social distancing. Only members of your barn are allowed in your barn aisle.
- In order to have as few people on the grounds as possible we ask that riders show up as close to their ride times as possible and don't linger when they are done competing. Only essential personnel (riders, trainers, grooms, show staff, veterinarian, farrier etc. are considered essential) are allowed on the grounds.
- The coffee shop will be open to serve cold food. We will not have community snacks or water available at this time. Please bring whatever food and beverages you may need for yourself but no "barn buffets" where multiple people are touching food or drinks
- Any person who does not follow these guidelines will be asked to leave the grounds and will not be given a refund.

- **SHOW OFFICE:** In order to limit contact with the show secretaries we ask that you email or fax your **COMPLETED** entry blank(s) with all classes, membership numbers etc. filled out, and health papers to [eglshow@aol.com](mailto:eglshow@aol.com). When you get to the show you can bring a method of payment to the office when you pick up your number(s). Nobody will be allowed in the office. All adds, scratches, shavings orders etc. will be done via text message to either 817-694-7196 or 817-929-5802.

### **HORSE HEALTH REQUIREMENTS**

- Negative Coggins within 12 months
- Health Certificate (CVI) with an inspection date within 21 days of arrival on GSEC grounds with a statement that says the horse has not been treated for a fever or any issue related to herd health in the last 30 days
- Vaccination records that show the horse(s) have been vaccinated for Flu and Rhino within six months of arrival date

## **All Classes**

- Must be shown in any legal bridle and bit
- NRHA Rule: Owner and exhibitor must have current 2020 NRHA Memberships
- NRHA Rule: Horse must have Competition License (transfers/new licenses can be made in show office)
- AQHA Rule: Exhibitors must have current AQHA card and AQHA Horse Registration papers
- Only one judge fee for concurrent classes
- Show stall per night \$40
- Shavings: \$12.00/bag; **No outside shavings**
- Grounds Fee: \$40.00/Horse/Day (un-stalled horse)
- R.V. Sites: \$40.00/night
- Office Fee: \$40.00/Horse; Youth only classes no office fee
- Video Fee: \$16.00 per horse

### STRHA 3K Conditions

- Limited to Non Pro Riders, STRHA with less than \$3,000, in lifetime reining earnings prior to current show year. **Must be a member in good standing of STRHA.**
- You must complete the class one-handed and all other NRHA rules apply.
